Course Description This course is designed to provide an overview of fundamental concepts of heat and mass transfer and transport processes in biological systems. Tests will be given at the date and time listed in the syllabus. No make-up tests will be given. You may drop one test score. The course notes used during lectures can be downloaded as pdf files from E-Learning. Problems and supplementary material will also be posted on E-Learning.

Learning Outcomes Upon completing this class, students will learn:

- Apply thermodynamics to biological systems
- Determine physical properties of the body fluids and cell membrane
- Determine physical and flow properties of the blood
- Human thermal system (heat losses through evaporation, convection, and conduction)
- Recognize relevance of transport principles in various applications in biomedical engineering
- Determine which laws/data are applicable to a specific biological system and process

Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent’s School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean.
